产品适用范围/Application of the Product

For screening of pipe joint and fitting in system for fuel oil, lub. oil and other flammable oil to prevent oil spray onto the source of ignition required by CCS Rules and SOLAS Convention. Approval conditions:

1. For use on pipe and joint of : Max. temperature: 150°C; Max. pressure: 2.0MPa; Nominal pipe dia.: up to 50mm for screwed joint and

300mm for flanged joint.

2. Restricted to oil pressure pipe located above the floor plates and which have no insulation in way of the joint. Use is also restricted to readily accessible positions where the integrity of the application may be inspected regularly and new covering will be applied after removal for maintenance purposes.

3. The NoSpray tape and sheet to be installed according to the manufacturer's instruction.

4. The NoSpary protection system not to be used for pipe insulation or as replacement for pipe gasket and sealing.

认可保持条件/ Maintenance Requirements of Approval

1. 型式认可后,如果产品及其重要零部件的设计、所用材料或制造方法有所改变,且影响到产品的主要特性、特征;或产品的性能指标有所更改,且超过认可的范围,则有关图纸和文件应经检验机构审批。并在检验机构认为必要时,经本社检验人员见证有关试验和进行检查,其结果应能证实仍符合认可条件。

After type approval, if there are changes to the design, materials used or manufacturing method of the product and important components and such changes affect major characteristics and properties of the product, or property indexes of the product are changed and exceed the scope of approval, related drawings and documents are to be examined and approved by the concerned survey office. Where deemed necessary by the survey office, the surveyor to the Society will go to witness relevant tests and conduct inspection and the results should be able to demonstrate compliance with the approval conditions.

2. 工厂的质量管理体系应保持有效运行,并且与认可时一致。如果质量管理体系发生改变,应经原体系认证机构审核并报本社批准。

The quality management system of the factory shall be ensure effective operation, and shall be the same as the situation of approval. If there are any changes to the quality management system, auditing of the original certification organization for quality management system and the society's approval shall be obtained.

3. 认可证书有效期内,如果出现可能导致本社取消认可的情况,工厂应及时采取有效的纠正措施。 Within the validity of the approval certificate, if cases occur that may cause the Society to withdraw the approval, the manufacturer should take corrective actions in a prompt and effective manner.

4. 在认可证书有效期内,本社检验人员可在未经事先通知的情况下对工厂的产品制造过程进行审核,以验证产品的生产是否符合业经本社批准的图纸和文件。工厂应予以配合。

Within the validity of the approval certificate, the surveyor to the Society may pay unannounced audit to the manufacturing process of the product in order to confirm whether it is in compliance with the drawings and documents approved by the Society. The factory should provide an active congration and processary for the surveyor.
